The September board of governor's meeting was held in the gym on the Milford campus on Tuesday, September 26.

The primary focus of the budget hearing and the board meeting was the vote on the proposed budget. The board voted to keep the tax levy flat.

I can tell you the board (and Dr Illich) all felt the pressure from the governor and legislature to make the decision to not increase the levy. Those who fought hard to make sure community colleges were *not* harmed (except the ones who have *already* been at their max for years) were blindsided by the last-minute antics by the governor's office in the days prior to the meeting.

Kirby Taylor presented testimony during the budget hearing. His points on manufacturing and equipment struck a chord with the board for sure! I spoke during the deliberations as well and mentioned how the delayed maintenance impacted us and that the HLC told us we needed to update our facilities to provide a better educational experience.

During the regular meeting, Carter Thiele, the LIBA/Chamber representative who spoke out in opposition of raising the levy, spoke during public comment again. He said he as "a little caught off guard" (and I would add mis-informed) about how the tax levy action would impact SCC. After he spoke to several from SCC during the break, he learned much more and said he "admires the passion of the board." He said in the long run this is for the "greater good." While Dr Illich and the board did SO much to try to educate the public at the open forums and the "pink postcard" hearing, people still did not have all the facts or only heard what they wanted to hear. I guess that's human nature.

This experience has certainly been educational for me as well. It makes me proud of the college and our faculty, but at the same time makes me disheartened that - unless someone has personal experience with an education at SCC - they really don't understand our mission and values.
