Call to Order: The meeting was called to order at 6:06 PM.

Corrections or Additions to Agenda: Ryan added 1 item which is election for Faculty Rep to the Board.

Approval of Agenda: Tyler made motion Susan seconded. Motion carried.

Approval of Minutes: Tyler made motion to approve minutes Vicki seconded. Motion carried. Bob Redler Abstained.

Treasurer's report – Susan reporting. Susan had emailed report out earlier today. Not much activity. Only real change is the retainer fee for FA attorney. Vicki made motion to approve treasures report, Tammie Seconded. Motion approved.

Faculty rep to the board report – The board of governors met on the Milford campus on Tuesday, September 24. The budget hearing was followed by the regular meeting.

Topics of interest:

- Budget for 2024-25 was approved. The spending list will be prioritized by the admin team in the coming months
- The legislative "future fund" will be paid to the college in 10 equal payments over the year
- Strategic Plan update board members participated in each of the listening sessions in the 15-county area.
 - o It was noted that at the Lincoln sessions there were primarily faculty and staff present rather than the general public. One board member mentioned that the board might consider listening sessions designated exclusively for faculty/staff in the future. The board and the employees learned a few new things about each other. ①
 - o ALL listening sessions indicated a shortage in health care workers

- Next step is to share the findings with the entire college during strategic planning week Oct. 7-11.
- Re-organization task force has met and is reviewing best practices for community college administration (i.e. Various roles/admin structure)
- The board held a closed session regarding a real estate update
- Dr. Bordenkircher from HLC will be attending the October board meeting. HLC representatives will be visiting prison locations in December
- There will be approximately 9-10 new programs/logical extensions presented at the November board meeting

October meeting will be held on Tuesday, October 15 on the Lincoln campus. Also note that the December 17 board meeting will be held at 1:00 to be completed in time for graduation that evening.

Grievance Report: Teresa Reporting. No action items currently.

President's report – SCC is moving forward with Faculty Counsel. Any FT faculty are welcome to nominate themselves. Email has been sent out to all faculty about this.

SkillsUSA is having fund raiser at "The Course" restaurant.

Campus Reports:

Lincoln – Teresa reporting. Not much else aside from President's report.

Beatrice – Tyler reporting. Not much activity. We will be hosting a 5K fun run on the 19th. Sports have started. Campus Elections were held. Kendra Sand was nominated for position of Treasurer.

Milford – Bob Reporting. Barry Smith has been nominated as Milford Campus Treasurer.

Committee reports: – Nothing to report.

Legal Counsel Report: Ryan. Spent some time discussing the Confidentiality practices and professionalism of being on this committee.

Unfinished Business: – Voting of members to Negotiations Team. This is a non-contract renewal year so actual negotiations should be brief.

- <u>FA Area Secretary</u> Kirby weas nominated by Tammie Bob seconded. Vote was taken and was unanimous.

The Executive team held elections for the Negotiations team and also the Chief Negotiator. Team members were nominated as follows:

All nominations were accepted and voted on. All voting was unanimous in favor of.

New Business:
